



# Diyar Al Muharraq







#### 01 Submitting the application

Submit your application using the e-Government portal by choosing New Mazaya, then enter the requested data and attach the required documents. Then sign a declaration via the "Family Members Declaration" service.



#### **03** Reservation of a land plot in Al Msayyan

Visit Eskan Bank to reserve your land plot in Al Msayyan.



#### **05** Final approval

The Ministry of Housing and Urban Planning will review the documents from the financing bank, then issue the final approval and a beneficiary subsidy certificate online.





#### **02** Eligibility process

The Ministry of Housing and Urban Planning will review your application and ensure compliance with the eligibility criteria. Upon approval, the Ministry will issue the Eligibility Certificate online.



#### 04

#### Applying for a financing scheme from participating banks

Visit one of the participating banks with all the required documents and the bank will issue you an initial offer letter.



#### **06** Final procedures

Eskan Bank will coordinate with you and the financing bank to finalize the process of New Mazaya to purchase the reserved land plot in Al Msayyan.
